Administration Response

When the website platform transitioned from Unity to Squiz we experienced some technical issues, however we are not certain if the missing agenda and minutes from 2016 was a direct result of this transition. Regardless the matter will be looked into and rectified.

Administration Response

Administration Response

At this stage, given that this project has yet to be formally endorsed by Council, there has been no consideration given to the actual design of the Warwick Street upgrade. However, Administration will discuss this option with the consultants, which will form part of the overall project for the draft 2020-21 budget.

What can Council do to assist businesses in Walkerville that are restricted to 10 people indoors, by providing space in the public realm where they may be able to trade within the government guidelines?



Response from Mayor

Thank you for the question Councillor. As some of you may know I was invited to speak on radio in relation to the potential to close streets to allow cafes and restaurants to trade. I think this is really great idea and one that I think we should get involved in, when the restrictions are eased. I also believe that we should reactivate the Business Liaison Forums and I have spoken to the Chief Executive about this.

Administration Response

Further adding to the Mayor's response, given the tight social distancing restrictions that currently apply around a maximum of 10 people able to enjoy outdoor dining, which will be relaxed to a maximum of 20 people from 8 June 2020, we will need to ensure that whatever Council considers does not breach the Directives issued by the Lead Agencies. Therefore, Administration will seek further clarity from the relevant authorities to ascertain if space in the public realm can be shared between businesses as suggested by Cr Williams.
