#### Mayoral Response

At a recent meeting of the Metropolitan Local Government Mayors and CEO's the matter you raised previously as it relates to e-planning provisions to the \$3.7mil being passed on to Local Government was discussed. It's our understanding that the total budget for that particular planning activity is \$28.4m and \$3.7mil is Local Government's share. This is one of many costs being imposed on Local Government and a resolution was passed at the meeting requesting the LGA provide information relative to this matter.
