He was a highly esteemed and well-regarded member of both the local community and wider South Australian region. I am reaching out to Dr Yung's family to pay our respects, but also wish to formally acknowledge the immense impact he had on so many people in the State. I also want to take this opportunity to assure the community that the security, safety and sense of wellbeing of our residents is of the utmost importance to Council. It is our goal to ensure all residents, students, workers and visitors feel safe within the local surrounds. We intend to liaise with SA Police to discuss potential ways to further support community safety initiatives at a Council level, and I encourage residents to contact myself or Councillors if you have any concerns.

### IN MEMORY OF ASHLEIGH YOUNG

I also wish to send my condolences to the family of Ashleigh Young, who passed away last week. Ms Young was a well-known figure in the area for her role in the sporting community. She was the Director of Sport and Recreation at Wilderness School and had an extremely positive influence on young women across multiple sports in South Australia, including through her work with the Norwood Football Club and the SANFL. We send our thoughts to Ashleigh's friends, family and sporting community.
