8.1 Questions from John & Sue Leatham - Gilberton Residents (received via email at 9:59am on 20 December 2021)

Question 1

The boundaries of Vale Park were established in 1961. Why is there now a push for realignment, given that it will incur considerable costs, and that it will be of no benefit to the great majority of ratepayers?

Response provided by Administration

At their meeting of 21 December 2020, Council passed the following Motion Without Notice:

CNC225/21-22

That Administration investigate the impact to and interest of residents bounded by Lansdowne Tce, North East Rd, Ascot Avenue and the River Torrens to be designated as part of the suburb of Walkerville rather than Vale Park.

Council's interest in this matter and reason for exploring the community's appetite was primarily due to this section of land being considered contiguous to Walkerville and non-contiguous to Vale Park; in that an arterial road separated the two sections of Vale Park.

The proposed realignment would align each respective suburb by bounding them by arterial roads.



Question 2

The weighted survey results regarding this proposal indicated that only 52% of respondents voted in favour. Why then has Council Administration been instructed to write to the Surveyor-General "with the view of proceeding to the next stage of the process", when the Surveyor-General "requires an overwhelming level of community support in order to proceed"?

Response provided by Administration

Council requested the Surveyor-General to provide his preliminary feedback on the findings of the consultation process as it is at the sole discretion of the Surveyor-General on whether to formally proceed, based on his perception of the results and whether there was an overwhelming response in favour of the change.

The Surveyor-General is presently considering the results presented – which include both weighted and unweighted results, with unweighted showing that 62% of the Township were in support of some form of boundary realignment/renaming and when confined to Vale Park ratepayers only, 82% were in favour of the change.

Question 3

What costs have been incurred to date regarding this process, including the report produced by Action Market Research consultants?

Response provided by Administration

To remain accountable, as well as a transparent tier of Local Government, Council regularly undertakes consultation with its community in order to gauge feedback. The cost for the Suburban Boundary Realignment/Renaming community engagement mailout – including the production, reply paid envelope and mailing costs to all Town of Walkerville ratepayers – was \$2,288.80 (exc. GST).

As part of consultation, 1,682 responses were received. In consideration of the unprecedented number of survey responses received during consultation, as well as to remain transparent throughout the process, Administration engaged marketing agency Action Market Research to provide an extensive overview of the results, to check for accuracy and potential duplication of survey submissions. The cost for Action Market Research's statistical analysis of consultation results – including data review, results presentation to Council and formal report – was \$2,500 (exc. GST).



Question 4

If the proposed boundary realignment/renaming were to proceed to completion, what would the approximate overall cost be?

Response provided by Administration

The expected costs associated with a boundary realignment/renaming are primarily associated with the community consultation process as undertaken by the Surveyor-General — of which Council will be expected to provide a contribution toward. Based on previous discussions with the department, costs associated with the consultation process are estimated to be up to and including \$10,000.

The full breadth of associated costs will be determined prior to conducting any future consultation process.

Question 5

What portion of this cost would be attributed to Walkerville Council ratepayers?

Response provided by Administration

Any costs associated with a contribution toward community consultation will be absorbed into the annual budget.

It is noted that the Presiding Member made an allowance for all five questions raised to be asked and answered, although the relevant Council Policy restricts the amount of questions per person to two.
