10.1 Cr Williams

Question:

It has been two months since we've had a meeting regarding the Bowling and Sports Club Redevelopment (December 2022). I am unable to answer questions from the community. My question is, what is going on?

## Mayoral Response:

The President of the Walkerville Sports Club has reached out to myself and the Acting CEO to ask whether they will be able to play a full season of football on the oval this year, and the answer is yes as we will not be in a position to build prior to September/October 2023.

## Administration Response:

- Acting CEO: I am not sure which meeting you are speaking of as there were no meetings in December scheduled for discussion about the oval. There may have been reference to a general briefing session.
- Mayor Jones: I think there was going to be a meeting with the architects.
- Cr Williams: No there was a meeting to be held to discuss an alternate.
- Acting CEO: Following the Informal Gathering, there were comments made about specific design amendments, the Architects were engaged to make some changes. There was also the Christmas break in that time. We received information about the design late January 2023, and we are now in receipt, as of last week, a report regarding costings and updates, which will be presented to Council on Monday evening (27 February 2023) at a Briefing Session.

- Cr Williams: I recall there being discussion around some alternative design having been drafted that Council were going to see, I'm sure other members remember as well.
- Acting CEO: Not quite accurate Cr Williams, I appreciate where you're coming from and I know what you are referring to, but there has not been an alternative plan drafted for the oval. What was talked about was some original sketches done by our internal staff that were looking at options for potential value management for the design itself, so I have to reiterate there has been no alternate design done for that site, except for the options that are currently on the table.
- Cr Williams: My understanding was that the other sketches, we were going to see but we haven't.

Mayor Jones: I'll ask that those come to the meeting on Monday night.

#### Question:

This is more a matter of process. Referring to the item regarding the SANTOS Tour Down Under (Item 14.3.3), but also correspondence in general. I am wondering what the correspondence was and whether we could have that sort of correspondence included into the agenda. What date was the correspondence received?

Acting CEO: Absolutely we can make sure such items come into the agenda as part of items in the future.

Group Manager Public Relations and Community Services:

This particular item was sent to us through the State Government commercial in confidence, so that is why it was not included as part of the report. It was received at the start of January 2023.

e: My concern is something like this is a Council matter, not Administration. I think we should be discussing our appetite to host such an event. I see this as an economic development opportunity. I would have liked for this to have been discussed.
