



### Register of Elected Members Allowances & Benefits for the period 01 July 2023 to 30 June 2024

Section 76 of the Local Government Act, 1999 (the Act) provides that each member of a Council entitled to receive an allowance from the Council for performing and discharging official functions and duties and are determined by the Remuneration Tribunal.

- (a) reimbursement of prescribed expenses (refer Local Government (Members Allowances and Benefits) Regulations 2010); and
- (b) reimbursement of prescribed expenses approved by the Council (either specifically or under an appropriate Policy adopted by Council).

Section 79 of the Act requires the Chief Executive Officer to keep a record (the 'Register of Elected Members' Allowances and Benefits') which, in respect of each Member of Council will contain:

- (a) the annual allowance payable to the member; and
- (b) details of any expenses reimbursed by the Council under Section 77((1)(b)); and
- (c) details of other benefits paid or payable to, or provided for the benefit of, the member by the Council.
